

The following was introduced by Mr. Ronald Menard and duly seconded by Mr. Cloris Boudreaux, and duly resolved,

**ORDINANCE NO. 2016-0-08**

**AN ORDINANCE REVISING CERTAIN ELECTION PRECINCT BOUNDARIES OF VERMILION PARISH, PREVIOUSLY ESTABLISHED BY ORDINANCE 2011-0-18 AND AMENDED BY ORDINANCE 2015-0-10, PROVIDING FOR THE MERGER, CONSOLIDATION AND RELOCATION OF PRECINCTS AS AUTHORIZED BY LOUISIANA REVISED STATUTE R.S. 18:532, 18:532.1, AND 18:532B(4)(a)(i)**

**WHEREAS**, R.S. 18:532.1 allows for the merging of precincts within a parish, and

**WHEREAS**, other portions of R.S. 18:532, allow for the consolidation of precincts having less than 300 registered voters, and

**WHEREAS**, R.S. 18:532B(4)(a)(i), allows for an exemption for an unincorporated and geographically isolated area.

**NOW, THEREFORE BE IT ORDAINED** by the Vermilion Parish Police Jury that the following sections shall be authorized and approved:

Section 1. The following precincts shall be merged as detailed:

1) Precinct 20A-1 (176 Voters), located at Kaplan High School, and Precinct 6 (579 Voters), and Precinct 9 (905 Voters) both located at Kaplan Elementary School, are all merged and designated as **Precinct 6** and located at Kaplan Elementary School.

Section 2. The following Precincts shall be consolidated and shall be manned by one set of commissioners handling all books:

1) Precinct 7A-1 (130 Voters) and Precinct 7B (722 Voters), both located at Indian Bayou/Andrew Fire Department.

2) Precinct 8B (343 Voters) and Precinct 10A (761 Voters), both located at the Rene Rost Elementary School.

3) Precinct 12 (784 Voters) and 20A-2 (210 Voters), both located at Kaplan High School.

4) Precinct 19A-1 (356 Voters), Precinct 19B (30 Voters), and Precinct 19A (1154 Voters), all located at Meaux Elementary School.

5) Precinct 21 (127 Voters), Precinct 21A (317 Voters) and Precinct 41 (164 Voters), all located at the Public Works Building.

6) Precinct 25A (258 Voters) and Precinct 25 (1659 Voters), both located at Cecil Picard Elementary School.

7) Precinct 26 (721 Voters) and Precinct 26A (550 Voters), both located at Cecil Picard Elementary School.

8) Precinct 32B (380 Voters), Precinct 34 (670 Voters) and Precinct 34A (315 Voters), all located at Gulf Area LTC (BCS Center).

9) Precinct 36A-1 (313 Voters) and Precinct 39 (508 Voters), both located at J.H. Williams Middle School.

10) Precinct 42A (916 Voters) and Precinct 42B (83 Voters), both located at Abbeville High School.

11) Precinct 46B-1 (534 Voters), Precinct 46B-2 (255 Voters), and 46B-3 (290 Voters), all located at Herod Elementary School.

12) Precinct 49B-2 (213 Voters), Precinct 50A (947 Voters), both located at the Erath City Court.

13) Precinct 57A (894 Voters) and Precinct 57B (187 Voters), both located at the Henry Fire Department.

Section 3. The following Precinct is considered to fall under the exemption provision of R.S. 18:532B(4)(a)(i), an unincorporated and geographically isolated area:

1 )Precinct 16 (136 Voters), located at the Pecan Island Fire Station.

Section 4. The following Precincts will be left as is:

Precinct 1 (1214 Voters), Precinct 2 (881 Voters), Precinct 5A (409 Voters), Precinct 10A (761 Voters), Precinct 11 (721 Voters), Precinct 14 (1523 Voters), Precinct 18 (1716 Voters), Precinct 20B-1 (406 Voters), Precinct 23 (803 Voters), Precinct 24 (637 Voters), Precinct 28 (887 Voters), Precinct 29 (862 Voters), Precinct 35 (718 Voters), Precinct 37 (1068 Voters), Precinct 38 (680 Voters), Precinct 40 (1025 Voters), Precinct 44 (587 Voters), Precinct 45A (460 Voters), Precinct 46A (644 Voters), Precinct 46B-4 (718 Voters), Precinct 49B-1 (2073 Voters), Precinct 51 (762 Voters) and Precinct 53 (1683 Voters).
